1 AUTHORITY:

The event will be held under the International Sporting Code of the FIA and the National Competition Rules of the Confederation of Australian Motor Sport Ltd (CAMS), the Speed Event Standing Regulations, the Short Circuit Standing Regulations, the Short Circuit Vehicle Regulations, Short Circuit General Regulations, these Supplementary Regulations and any further regulations or instructions which may be issued in respect to CAMS Permit Number: 411/3010/02.

The Speed Event Standing Regulations refers only to the super sprints. The Short Circuit Standing Regulations, Vehicle Regulations and General Regulations refers only to the short circuit.
